Collectively the entrepreneurial companies listed produce combined revenues of \$185.4 billion annually and showed an average 3-year growth rate of 334 percent. SellMyTimeshareNOW.com showed a revenue increase from \$1.1 million in 2004 to nearly \$7.0 million in 2007 (the period used by Inc.com for evaluating the companies nominated to their 2008 list).

To qualify for the Inc. 5000 list, companies must be privately held, US owned, for profit, independent businesses. They cannot be subsidiaries of other companies and as of December 31, 2007 must have had at least \$200,000 in revenue in 2004, and at least \$2 million in revenue in 2007.

"The Inc. 5000 gives an unrivalled portrait of young, underreported companies across all industries doing fascinating things with cutting-edge business models, as well as older companies that are still showing impressive growth." said Inc. 5000 Project Manager Jim Melloan.

SellMyTimeshareNOW.com began with just 3 employees, listed 112 employees at the time it was evaluated to make the Inc. 5000 list, and has continued to grow to more than 130 employees today.
